AN ORDINANCE AMENDING CHAPTER 16 OF THE GLOUCESTER COUNTY CODE TO ADD SECTION 16-44 - ASSESSMENT OF PROBATE TAXES

Pursuant to the authority of Section 58.1-1718 of the Code of Virginia the proposed code amendment will impose a county tax in an amount equal to one-third of the amount of the state tax on the probate of every will or grant of administration.

**AN ORDINANCE AMENDING CHAPTER 16 OF THE
GLOUCESTER COUNTY CODE TO ADD
SECTION 16-44 – ASSESSMENT OF PROBATE TAXES**

WHEREAS, the Gloucester County Board of Supervisors desires to amend the Gloucester County Code by adding a section concerning probate taxes; and

WHEREAS, the Gloucester County Board of Supervisors is authorized to impose this tax by Va. Code Section 58.1-1718; and

WHEREAS, the Board of Supervisors has held a duly advertised public hearing.

NOW, THEREFORE BE IT ORDAINED AND ENACTED, by the Board of Supervisors of Gloucester County, Virginia, this 2nd day of March, 2010, that the Gloucester County Code, Chapter 16, is hereby amended to add Section 16-44 to read as follows:

Sec. 16-44. Assessment of probate tax.

Pursuant to the authority of Section 58.1-1718 of the Code of Virginia, and all amendments thereto, there is hereby imposed a county tax on the probate of every will or grant of administration as provided in Section 58.1-3805 of the Code of Virginia, and all amendments thereto. Such tax shall be in an amount equal to one-third of the amount of the state tax on such probate of a will or grant of administration.
