New Legislation allows voters who miss this deadline above to use Same Day Registration to Register & Vote only a Provisional Ballot that will be reviewed after the Election by the Electoral Board. So please register to vote or update your information by **October 17, 2022!**

Reminder: Bring acceptable ID to vote at your polling location, Polls are open from 6am - 7pm and be sure to thank your Election Officials who are serving you to ensure the integrity of the elections. These are your family, friends and neighbors working for their community!

BALLOT DROP BOX: The Official Gloucester County Ballot Drop Box continues to guarantee ballot security and offer a safe and easy way for voters to return their requested ballots in a drive-through outside our office, that is under 24/7 video surveillance. It will be opened for use on Friday, September 23, 2022.

Important: When returning your Absentee Ballot by mail or through the Ballot Drop Box, please be sure to enclose your ballot in "Envelope B" completed, sealed and inside of the pre-paid postage envelope provided.

Please note: Once you request an Absentee Ballot you are marked as already voting AB in this election. If you change your mind and want to vote In-Person on Election Day, you **must** return the unvoted Absentee Ballot to vote normally or you will be required to vote a provisional ballot.

BALLOTS: We will mail out all the current requested Absentee Ballots we have received on Friday, September 23, 2022. The Sample Ballot has been posted to our website. We now have 11 different Ballot Styles by our 11 different precincts, required by new legislature for reporting purposes. All of our ballots have the same candidates listed below for Member House of Representatives in the 1st District for our county.
